3.1 Macdonald Campus Security Services (Informational, Discussion)

Aidan Hayward Toland (VP Finance) presented:

McGill Security Services are requiring MCSS to sign a Service Level Agreement (SLA). We are not ready to sign yet, as we need time to determine if the agreement represents our best interest. The newly imposed cost of security agents might force MCSS to hold a referendum to create an additional fee, paid by students to offset the expense.

We have a <u>survey on Instagram</u> right now to evaluate what students feel about the Mac Campus security services.

3.2 MCSS Health & Dental Fee Referendum (Info, Discussion)

Vaishnavi Parey (President): Aidan Hayward Toland (*VP Finance*) and herself will be meeting with our representative at Studentcare on Dec 5th, to go over the cost of the MCSS Health & Dental plan. The fee has not been raised since 2016, so we are now at a substantial deficit. We will hold a referendum for the fee renewal and increase next semester.
