### **3.3 SPF Annual Report with special guest Shona Watt (Info, Discussion)**

Special Guest: **Shona Watt** (*Sustainability Manager, McGill Office of Sustainability (MOOS)*) presented the SPF Annual report:

Some key points about the Fiscal Year 2025 SPF Annual Report:

- The report covers the period between May 1, 2024-Apr 30, 2025
- In its lifetime, the SPF has allocated over \$12.9 million in funding and has approved 408 projects, including at Mac campus
- This year, 59 applications were received, and 39 projects were approved, including ones at Mac e.g. Thrift McGill, Mac Sustainable Menstruation Initiative

### **3.4 Collaboration with Campus Life & Engagement for midterm campaign at Mac Campus (Info, Discussion, vote) Joshua Cao (VP Internal)**

He was contacted by Caroline Arpin, Student Life Advisor from Campus Life & Engagement who would like to reach out to students at Mac during midterms.
